LD AN ACT TO ENSURE THAT THERE IS NO PENALTY FOR LVWD 443 EARLY RETIREMENT AFTER 30 YEARS OF TEACHING

Sponsor: HANDY, Joseph, Warren, Paradis J Committee Report: LVWD

SUMMARY: The bill would have allowed teachers who had taught for 30 years or more, at least 20 of that service being in Maine, to retire before age 60 without any reduction in pension because of early retirement.

LD AN ACT TO EXTEND CERTAIN PRIVILEGES TO DISABLED PL 1987
481 AMERICAN VETERANS C. 352

Sponsor: TRACY, Kany, Hickey, Nutting Committee Report: OTP

SUMMARY: The bill extends two privileges to veterans who are 100% disabled. First, it entitles the veteran to a complimentary hunting or fishing license. Second, it removes the requirement that a disabled veteran had to have served in a combat zone in order to qualify for a free special automobile license plate.

SUMMARY: The bill provides for a continuation of the Commission to Study the Integration of the Maine State Retirement System with the United States Social Security System. The Commission submitted a report at the beginning of the present Legislature comparing the benefits of the two systems. In the second year, the original draft would have provided money for the commission to work with the actuary of the Maine State Retirement System to develop a specific proposal to provide a new option within the Maine

State Retirement System which would function as a true supplement to Social Security. At present many of the benefits are duplicative resulting in unnecessary expense to both employers and employees.

The committee amendment (S-5) made small changes in the appropriation reflecting a surplus from the previous year. The senate amendment to the committee amendment (S-271) removed the money for the actuary. As passed the commission will act as an advisory group to the Maine State Retirement System.

SUMMAR: The bill makes it clear that participants in the Maine Legislative Retirement System can participate in the group life insurance program offered to state employees.

AN ACT TO REDUCE THE RETIREMENT AGE REQUIREMENT PL 1987
702 FOR GOVERNORS C. 422

Sponsor: PARADIS P, Hickey, Perkins Committee Report: New Draft of LD 60

SUMMARY: The original draft of the bill (LD 60) reduced the retirement age of former governors from age 65 to age 60. The new draft retained this change and added several clarifications.

The new draft makes it clear that the pension of the former governor is calculated as of the time the former governor reaches age 60. In addition, it changes the spouses benefit. If the former governor dies after reaching age 60 and the spouse is age 60 or over, the spouse's pension is calculated as a continuation of the former governor's benefits. If the governor was under age 60 and the spouse
