SUMMARY: The bill as amended provides statutory authority for a Retired Judge of the Administrative Court to be appointed as an Active Retired Judge of the Administrative Court. Thus, an Active Retired Judge of the Administrative Court may, upon assignment, sit in the Administrative Court, District Court, or Superior Court.

LD AN ACT TO ABOLISH JOINT AND SEVERAL LIABILITY CARRY-OVER 526

SUMMARY: The bill seeks to abolish the joint liability of defendants in actions for personal injury, property damage,

or wrongful death. Each defendant is to be liable only for the portion of damages attributable to the defendant's percentage of the fault.

LD AN ACT REGARDING LIABILITY FOR FOSTER PARENTS 535 FOR CHILDREN AND ADULTS

CARRY-OVER

Sponsor: CLARK, M., Cote Committee Report: Carry-Over

SUMMARY: The bill seeks to provide immunity from civil liability to foster parents of children and adult foster home providers when the foster parent is licensed, approved as meeting standards for licensure, or caring for a child at the request of the Department of Human Services pending licensure or approval. Such a foster parent would not be immune from civil liability for willful or intentional abuse or neglect, or for gross neglect that results in serious harm to the child or adult. In these cases of liability, the damages for a single occurrence are limited to \$10,000.

SUMMARY: The bill seeks to:

limit the compensation of a plaintiff in a personal injury action for noneconomic damages to \$250,000;

abolish the collateral source rule, thus permitting the admission into evidence of proof of collateral source payments made or substantially certain to be made to the plaintiff;

abolish joint and several liability, thus permitting a defendant to be liable only for the amount of damages proportionate to the defendant's percentage of the fault;
