LD AN ACT REGARDING LIABILITY FOR FOSTER PARENTS CARRY-OVER 535 FOR CHILDREN AND ADULTS CARRY-OVER

Sponsor: CLARK, M., Cote Committee Report: Carry-Over

SUMMARY: The bill seeks to provide immunity from civil liability to foster parents of children and adult foster home providers when the foster parent is licensed, approved as meeting standards for licensure, or caring for a child at the request of the Department of Human Services pending licensure or approval. Such a foster parent would not be immune from civil liability for willful or intentional abuse or neglect, or for gross neglect that results in serious harm to the child or adult. In these cases of liability, the damages for a single occurrence are limited to \$10,000.

LDAN ACT CONCERNING THE ATTACHMENT OF REALLVWD537PROPERTY AND PERSONAL PROPERTYLVWD

Sponsor: WARREN, Marsano, Stevens, P., Paradis, P. Committee Report: LVWD

SUMMARY: The bill sought to nullify all attachments of personal property after 5 years. The revisions suggested in this bill were addressed in LD 874.

LDAN ACT TO REFORM PROVISIONS OF THE CIVILCARRY-OVER539JUSTICE SYSTEM

Sponsor: TWITCHELL, Perkins, Vose Committee Report: Carry-Over

SUMMARY: The bill seeks to:

limit the compensation of a plaintiff in a personal injury action for noneconomic damages to \$250,000;

abolish the collateral source rule, thus permitting the admission into evidence of proof of collateral source payments made or substantially certain to be made to the plaintiff;

abolish joint and several liability, thus permitting a defendant to be liable only for the amount of damages proportionate to the defendant's percentage of the fault;

reduce current pre- and post-judgment interest rates from the current fixed rates of 8% and 15% to a floating rate tied to the rate paid on U.S. Treasury notes during the preceding 6 months;

provide immunity to officers and directors of nonprofit associations and corporations as long as their conduct is not willful, wanton, or grossly negligent;

establish a new standard of liability for product's liability cases; and

prohibit the inclusion in a civil case filed in Superior Court of the amount of damages sued for.

LDAN ACT TO FACILITATE MUTUAL AID AGREEMENTSPL 1987579BETWEEN MUNICIPAL POLICE DEPARTMENTSc. 106

Sponsor: CARTER, Paradis, P., Black, Gauvreau Committee Report: OTP-A Amendments Adopted: H-72 COMMITTEE

SUMMARY: The bill permits municipal officers to:

authorize the chief of police or other designee to request other municiplities to provide police officers to assist the requesting municipality; and

authorize the chief of police or other designee to provide police officers to another municipality requesting aid.

These authorizations must be accompanied by an agreement specifying which municipality shall assume liability for a police officer from one municipality rendering assistance to another.
