LD AN ACT TO REQUIRE MANDATORY CERTIFICATION OF  
576 ADULT DAY CARE SERVICES IN MAINE

SUMMARY: This bill establishes licensing procedures for adult day care facilities. The new draft amends the provisions of that licensing law to include facilities for adults under 60 years of age, to require the Department of Human Services to consult with interested agencies on rulemaking, to delay the effective date until July 1988 and to waive compliance with the licensing requirement for facilities already licensed.

SUMMARY: This bill, and the subsequent new draft, established a special commission to review overcrowding at the Augusta Mental Health Institute and the Bangor Mental Health Institute.
