LD AN ACT TO TRANSFER THE MAINE FIRE TRAINING AND 700 EDUÇATION PROGRAM FROM THE DEPARTMENT OF EDUCATIONAL AND CULTURAL SERVICES TO THE MAINE VOCATIONAL-TECHNICAL INSTITUTE SYSTEM

SUMMARY: LD 700 transfers the Firefighter Training Program from the Department of Educational and Cultural Services to the Maine Vocational Technical Institute System.

Previously this program was the responsibility of the Commissioner of Educational and Cultural Services. The Executive Director of the Maine Vocational Technical Institute System is given responsibility for the program by LD 700.

This bill was amended twice. One amendment corrected an omission from the original allocation and allocated money to the Maine Vocational-Technical Institute System to fund the Firefighter Training Program which has been transferred to that system.

The second amendment corrected an erroneous reference to the Commissioner of Educational and Cultural Services and changed the reference to the Executive Director of the Maine Vocational-Technical Institute System.

This amendment removed the allocation of special dedicated revenues in the Department of Educational and Cultural Services for the Maine Fire Training and Educational Program. This program is now under the jurisdiction of and administered by the Maine Vocational-Technical Institute System with the special dedicated revenues derived from the assessment on fire insurance policies and premiums.

LD AN ACT TO PROVIDE FOR ELECTION OF THE PUBLIC 708 ADVOCATE

SUMMARY: LD 708 proposed that the Legislature, in joint convention, elect the Public Advocate for a term of 4 years. In the event of a vacancy in the office during the period that the Legislature is adjourned, the President of the Senate would be authorized to appoint an interim Public Advocate who would serve until the Legislature convenes and elects the Public Advocate.

The Public Advocate is currently appointed by the Governor, reviewed by the Utilities Committee and confirmed by the Senate. The Public Advocate serves at the pleasure of the Governor.

SUMMARY: LD 742 would establish the Watershed District Commission which would have the duty to study issues concerning the creation and operation of lake management and watershed districts with a goal of providing statewide uniformity.

LD 742 was amended twice. The first amendment created 2 ex officio non-voting members of the Watershed District Commission. This amendment also provides that the Department of Environmental Protection and the Maine Land Use Regulation Commission will staff the Commission.

The second amendment eliminates one ex officio non-voting member and provides that only the Department of Environmental Protection shall provide technical assistance to the Commission.

LD AN ACT RELATING TO THE RIGHT OF STATE EMPLOYEES LVWD 748 TO SOLICIT POLITICAL CANDIDATES
