RESOLVE 1987 c. 7 EMERGENCY

SUMMARY: This Resolve is the annual county tax and authorization bill for Lincoln County.

LDAN ACT TO CLARIFY THE TAXING POWERS OF THE FRYE738ISLAND MUNICIPAL SERVICES CORPORATION

P&S 1987 c. 2 EMERGENCY

Sponsor: GREENLAW, Usher, Black, Brown Committee Report: New Draft of LD 420 Amendments Adopted: H-17 CARROLL

SUMMARY: In 1975 the legislature authorized formation of a Municipal Services Corporation which consisted of the whole area of Frye Island. The Corporation exists to perform many of the usual municipal services and has the power of taxation.

The original bill seeks to remove a portion of Frye Island that was erroneously included from the corporation and to abate all previous taxes incurred.

This new draft provides that the landowners of the southerly tip of Frye Island will not receive services from the Frye Island Municipal Services Corporation until they agree to become members of the corporation. Upon agreement to become members of the corporation, the landowners will become subject to the taxing authority and rules of the corporation. It also provides that if the landowners who have not been receiving services from the corporation pay some back taxes to avoid lien proceedings, the Corporation shall return that money within 30 days of the effective

date of this Act. Finally, it requires the corporation to discharge within 30 days of the effective date of this new draft any liens filed on the real estate excepted from its territory.

The amendment makes technical chages.

LDAN ACT TO VALIDATE CERTAIN PROCEEDINGS OF THEP&S 1987885TOWN OF TRENTONc. 8

EMERGENCY

Sponsor: PERKINS, Zirnkilton, Joseph, Salsbury Committee Report: New Draft of LD 277

SUMMARY: Referendum votes taken on 2 occasions authorizing the construction of an elementary school had errors in them which call into question the validity of proceeding with construction of the building. This bill validates these referenda.

This new draft is more specific and detailed than the original bill concerning the referenda being validated and the effect of this validation.

LD AN ACT RELATING TO MOORINGS FOR NONRESIDENTS LVWD 926

Sponsor: ROLDE Committee Report: LVWD

SUMMARY: Currently, mooring sites are to be reserved for non residents of a municipality in a number equal to 10% of those available for residents. This bill requires that municipalities completely take care of the mooring needs of residents before making moorings available to non residents.

LDAN ACT CONCERNING THE FEES RETAINED BYLVWD1008MUNICIPALITIES FOR PROCESSING CERTAIN LICENSES

Sponsor: INGRAHAM Committee Report: LVWD

SUMMARY: Currently, State law sets the fee that municipalities may charge for the costs included in processing state required licenses and permits. Generally, such fee is \$1. This bill authorizes the municipality to charge its actual cost for certain of these transactions, namely, dog licenses, hunting and fishing licenses, and motor vehicle registration.
