LD 456 AN ACT REGARDING THE 2-INCH CLAM LAW.

ONTP

Sponsor: WARREN, Kerry, Higgins
Committee Report: ONTP

SUMMARY: This bill sought to allow shellfish dealers to have undersized clams in excess of the 10% statutory tolerance, provided the bulk pile was graded. Dealers are having problems with the 10% tolerance of the 2 inch clam law. The sponsor argued that this law should be enforced on the clam flats and not at the wholesale/retail outlets. The department argued that the effectiveness of the law would be diminished if enforcement could only occur on the flats.

Because the 2 inch clam law is subject to review in March, 1988, the Committee felt they would delay consideration of this issue until that review is undertaken.

LD 762 AN ACT TO AMEND THE MARINE LICENSING LAW.

SUMMARY: This bill sought to remove the ability of marine wardens to search and inspect vehicles. The sponsor felt that in some instances this power had been abused. The Department felt strongly that this authority was vital for marine law enforcement.
