SUMMARY: LD 107 changed the appointing authority of the 2 legislative members of the Committee on Aging. Previously the Governor appointed all 15 members including the State representative and the State senator. LD 107 authorizes the Speaker of the House to appoint the representative and the President of the Senate to appoint the Senator to the Committee on Aging.

The following boards have previously (prior to termination) or currently have joint appointments by the Governor, the Speaker of the House, and the President of the Senate:

State Harness Racing Commission; Citizens Civil Emergency Preparedness Commission; Community Services Advisory Board; Maine Correctional Advisory Commission; State Energy Resources Advisory Board; Low Level Waste Siting Commission; Maine Council on Alcohol and Drug Prevention and Treatment; Maine Committee on the Problems of the Mentally Retarded; Whitewater Advisory Committee; Whitewater Safety Committee; State Compensation Commission; Maine Human Services Council; Maine Commission for Women; Commission on Intergovernmental Relations; Commission on Interstate Cooperation.

The new draft rewrote the bill to reorganize the statutory provisions in a more meaningful and clear manner without changing the substance of the law. A technical change was also included.
