LD AN ACT TO ENHANCE THE PRODUCTIVITY OF THE 855 WORKERS' COMPENSATION COMMISSION

PL 1987 c. 452 EMERGENCY

Sponsor: MICHAUD, Willey, Begley, Foster Committee Report: OTP-A Amendments Adopted: H-64 COMMITTEE H-75 MCHENRY

<u>SUMMARY:</u> LD 855 proposed to add an additional workers' compensation commissioner to make a total of 10 commissioners.

The Committee Amendment (H-64) added an appropriation section to the bill.

The House Amendment (H-75) made the bill an emergency and adjusted the appropriation accordingly.

LD AN ACT CONCERNING THE PAYMENT OF UNEMPLOYMENT LVWD 861 INSURANCE BY WORKERS IN THE KNITTED OUTERWEAR INDUSTRY

Sponsor: SIMPSON, Rand, Joseph Committee Report: LVWD

<u>SUMMARY:</u> LD 861 proposed to make an unemployment tax exemption for home knitters, enacted in 1986, retroactive to January 1, 1982.

LD AN ACT TO INCREASE THE FAMILY ALLOWANCE OF THE ONTP 875 UNEMPLOYMENT COMPENSATION LAW

Sponsor: PRIEST, Michaud, Clark H, Usher Committee Report: ONTP

SUMMARY: LD 875 proposed to increase the family allowance provided for unemployment compensation recipients from \$5/week for each child, to \$20/week for each child.

LD AN ACT TO CLARIFY THE DISCRIMINATION PROVISION LVWD

899 OF THE WORKERS' COMPENSATION ACT SO THAT

SUMMARY: LD 899 proposed to amend the anti-discrimination provision of the Workers' Compensation Act to increase

potential damages to include triple back wages and any other financial losses resulting from the discrimination. The bill also attempted to describe the actions taken by an employer that would constitute discrimination.

LD AN ACT TO EXTEND THE FREEZE ON MAXIMUM WEEKLY PL 1987
916 BENEFITS UNDER THE WORKERS' COMPENSATION ACT C. 156

Sponsor: EMERSON, Twitchell, Committee Report: OTP-A Amendments Adopted: S-59 COMMITTEE

SUMMARY: LD 916 proposed to extend the current freeze on the maximum level of workers' compensation weekly benefits for an additional 3 years until July 1, 1990.

The Committee Amendment (S-59) reduced the extension to one month, from July 1, 1988 to August 1, 1988.

LD AN ACT CONCERNING THE AMOUNT OF EXTENDED BENEFITS LVWD 929 UNDER THE EMPLOYMENT SECURITY LAW

Sponsor: WILLEY, Emerson, Twitchell Committee Report: LVWD

<u>SUMMARY:</u> LD 929 proposed to reduce the state's share of any extended unemployment benefits paid by the state in the same proportion as the Federal Government reduced its share of the benefits under the Gramm-Rudman Act.

LD AN ACT TO PROVIDE DUE PROCESS IN UNEMPLOYMENT CARRY-OVER 1029 INSURANCE APPEALS

Sponsor: MARTIN, Dutremble, McHenry Committee Report: CARRY-OVER

SUMMARY: LD 1029 proposed to change the current appeals process within the Bureau of Employment Security. The bill creates a new office of Administrative Law Judges to hear and decide appeals from decisions of the deputies in unemployment compensation cases; this office would assume the function currently performed by Appeal Tribunals within the Bureau of Employment Security. The bill further removes the Appeals Division of the Bureau of Employment Security to place it under the Maine Unemployment Insurance Commission, an independent entity with its own budget, subject to initial approval of the Commissioner of Labor.
