AN ACT TO ALLOW THE EMPLOYMENT OF PART-TIME SUPERINTENDENTS OF SCHOOLS.

PL 1987

Sponsor: VOSE

Committee Report: OTP-A

Amendments Adopted: H-191 COMMITTEE

<u>SUMMARY:</u> This bill allows school administrative units to employ a superintendent part-time.

H-191 - The committee amendment makes a technical amendment to separate provisions dealing with part-time employment from provisions dealing with full-time employment of superintendents and to place each in a separate subsection.

LD AN ACT TO EXTEND THE REPORTING DEADLINE FOR THE PL 1987
1300 TEACHER AND ADMINISTRATOR CERTIFICATION STUDY. c. 84

Sponsor: ESTES, Bost

Committee Report: NOT REFD TO COMTE

SUMMARY: This bill extended the reporting date of the Joint Standing Committee on Education on its review of the teacher and administrator certification laws from prior to April 1, 1987 to prior to May 1, 1987. The bill was enacted without reference to committee.

AN ACT RELATING TO SCHOOL CONSTRUCTION.

INDEF. PP

Sponsor: CLARK N, Perkins, Soucy, Hichborn Committee Report: New draft of LD 137

SUMMARY: The original bill would have increased the debt limit on new school construction from \$35 million to \$55million.

The new draft retained the new \$55 million limit but changed the basis upon which the limit was to be calculated. Under present statute the limit is on the actual debt service. The new draft proposed putting the limit on the amount approved by the State Board of Education. Since not all of the projects approved are actually funded at the school unit level, basing the limit on approvals rather than actual debt service would have eased the State Boards problem in estimating the number of projects they can approve. In addition, since there is a built-in lag between the State Board's approval, a school

unit's referendum on the project, and the issuance of bonds, raising the approval limit would not have resulted in an increase this biennium but would have phased the cost increase in over the following two bienniums.

The new draft also added a provision that the \$55 million authorization limit would have been increased by an inflation adjustment based on the previous three years changes in the cost of construction.

Finally the new draft added a provision requiring school units to make a 5 year projection of building size needs in any request of school construction.

LD AN ACT TO AMEND THE WELLS-OGUNQUIT COMMUNITY ONTP 1360 SCHOOL DISTRICT CHARTER.

Sponsor: ESTES

Committee Report: ONTP

SUMMARY: The bill concerned a perennial problem stemming from dissatisfaction by residents of Ogunquit with the local cost sharing formula in the Wells-Ogunquit CSD. Under their present formula the two towns share costs 100% on the basis of state valuation. The proposal would have been to move in phased steps to a formula based 25% property valuations and 75% student count.

EMERGENCY

Sponsor: JOSEPH, Rolde, Handy, Randall Committee Report: New draft of LD 384

SUMMARY: The operative language in both the original and the new draft is the same. Both bills would have eliminated fees for GED examinations. The fees are used to fund the departmental administration of the GED program. The funding for the program would have been transferred to the state General Fund. The New draft also added an emergency preamble, an allocations and appropriations section, and a fiscal note.
