LD 1557 AN ACT TO IMPROVE THE ABILITY OF THE DEPARTMENT OF AGRICULTURE, FOOD AND RURAL RESOURCES TO RESPOND CONSTRUCTIVELY TO COMPLAINTS OF INSECT INFESTATION.

Amendments Adopted: S-207 COMMITTEE

SUMMARY: Present law requires entomologists employed by the Department of Agriculture, Food and Rural Resources refer cases of insect infestation which are a public nuisance arising from other than normal agricultural or fishing activities to the Attorney General for action.

The bill shifts the requirement to the Commissioner and provides for Departmental efforts to resolve the problem prior to referral to the Attorney General. The statement of fact states that intent of removing the department's responsibility in cases not involving agricultural activities, but the bill is not entirely clear on that point.

LD AN ACT TO CONTINUE ON AN ANNUAL BASIS THE
1588 REGISTRATION FEE CHARGED TO PESTICIDE
MANUFACTURERS AND OTHER REGISTRANTS IN 1987.

Amendments Adopted: H-213 COMMITTEE

SUMMARY: Present law requires pesticide manufacturers and distributors to pay an annual registration fee for each pesticide product they intend to market in the State. In 1986, that fee was increased from \$60 to \$75 for the 1987 calendar year. This bill makes the increase permanent.

These fees constitute the majority of the revenues available to fund the Board of Pesticides Control. With the increase, in FY 1988 projected revenues are: General Fund \$99,000; Federal Grants \$105,000; and Fees \$320,000, and there are some carryover funds. Projected expenditures are \$544,000.

The Committee Amendment (H-213) added a fiscal note indicating increased revenues of \$64,000 in FY 88 and \$78,000 in FY 89.
