LD AN ACT TO AMEND THE UNDERGROUND OIL STORAGE 1507 FACILITIES AND GROUND WATER PROTECTION LAW.

Sponsor: WILLEY, Sewall, Usher, Hepburn Committee Report: OTP-ND-NT LD 1763

SUMMARY: See New Draft LD 1763.

LD AN ACT TO IMPROVE THE STATE'S CAPABILITY TO 1528 RESPOND TO A HAZARDOUS MATERIALS INCIDENT.

ONTP

Sponsor: BICKFORD, Gwadosky, Farnum, Gill Committee Report: ONTP

SUMMARY: The bill provided a General Fund appropriation to support a training program in hazardous materials handling and to improve the State's emergency response capabilities for accidents involving hazardous materials. The bill was originally referred to the Appropriations Committee which rereferred the bill to the Energy and Natural Resources Committee. The bill came late in the Session and lacked a funding mechanism.

LD AN ACT TO IMPROVE THE EFFECTIVENESS OF EXISTING ONTP
1580 STATE LAND USE LAWS AND TO PROMOTE CONSISTENCY
AMONG THEM.

Sponsor: COLLINS, Anderson, Hanley Committee Report: ONTP

SUMMARY: This bill was proposed by the Governor for the purpose of consolidating four existing land use laws, the Great Ponds Program, Alteration of Coastal Wetlands, Alteration of Rivers, Streams and Brooks, and the Freshwater Wetlands Act. The intent of consolidating these statutes was to provide a single source of regulation and a single set of standards for state permitting in natural resource areas important to the state. The first four sections of the bill repeal the current statutes; section five enacts 38 MRSA c. 22, Natural Resource Protection. Achieving consistency among statutes resulted in some changes in definitions and standards from current statutes. Other provisions deal with cumulative impacts, delegation to municipalities of permit-granting authority, the elimination of exemptions for agricultural and forestry activities in freshwater wetlands, and the adoption of performance and use standards by the BEP. The State Planning Office proposed an amendment to the bill that added a findings and purpose section and some technical corrections.

The committee withheld support from this bill for three reasons; its late introduction, the need to deal first with other legislation, and the presence of several other land use related bills. These bills included L.D.s: 1284, 1442, 1617, 1647, and 1764 (a new draft of 1442). As a result of these factors, a study of land use and economic development issues will be conducted during the interim between the first and second regular sessions of the 113th Legislature.

LD AN ACT TO CHANGE THE WATER QUALITY PL 1987
1596 CLASSIFICATION OF THE CARRABASSETT RIVER AND C. 189
CERTAIN OF ITS TRIBUTARIES.

Sponsor: DEXTER, Holloway Committee Report: New Draft of LD 961

SUMMARY: The original bill upgraded the classification of a portion of the Carrabassett River mainsteam from class B to class A. In reviewing the actual water quality of the mainsteam and its tributaries, the committee unanimously decided to amend the bill to also upgrade the classification of various tributaries to class A.

LD AN ACT TO ESTABLISH THE WELL WATER INFORMATION PL 1987 1597 LAW. C. 509

Sponsor: MITCHELL, Coles, Mills Committee Report: New Draft of LD 265 Amendments Adopted: S-254 PEARSON

SUMMARY: The original bill required all well drilling contractors to report on the characteristics of all wells that they construct. The committee unanimously adopted a new draft which made several technical corrections, lengthened the reporting period from 45 to 180 days and made provisions to limit the public availability of the data. The new draft exempts the data from the Freedom of Access Act in order to allow the Maine Geological Survey and other state agencies who subsequently acquire the data to limit public access to the individual well records.
