SUMMARY: This bill amends the procedures for the Emergency Medical Services Board to act on license revocation and suspension. It requires a 2/3 vote and at least 1/2 the membership must have voted on that motion. The formal adjudicatory hearing must be conducted by the Department of Human Services hearings unit and the final decision rests with the commission.
