All Adopted Amendments are listed, by paper number (e.g., H-584 or S-222), together with the sponsor if it is a floor amendment or the designation "COMMITTEE" if it is a committee amendment.

Final action for each bill is listed to the right of the title. If final House action and Senate action differ, both are listed.

The New Draft allows any federally-recognized Indian tribe to hold high stakes beano games on its reservation. The license fee is 5% of gross proceeds and persons operating the games, except for persons providing specific professional services, may be paid no more than minimum wage.

The New Draft allows all beano licensees to conduct one "winner-take-all" round per occasion. It also slightly raises all beano fees.

LD AN ACT TO GIVE LOCAL ELECTION WARDENS AUTHORITY PL 1987
1643 CONCERNING GATHERING PETITION SIGNATURES c. 225

Sponsor: WEBSTER, M., Cashman, Begley, Theriault Committee Report: New Draft of LD 1145

<u>SUMMARY:</u> The original bill would give the election warden at each voting place the authority to select a location at the voting place where persons may collect petition signatures.

The New Draft gives the warden that authority, but the location selected must be accessible to and observable by the voters. The warden may limit the number of people collecting signatures to one for each specific question, candidate or issue. Persons collecting signatures may not solicit a voter's signature until the voter has completed voting.

LD 1644 AN ACT CREATING A STUDY ON UNIFORM LIQUOR PRICING AND OTHER FACTORS IN THE OPERATION OF THE STATE LIQUOR COMMISSION AND THE BUREAU OF ALCOHOLIC BEVERAGES

P&S 1897 c. 69 EMERGENCY

Sponsor: JOSEPH, McHenry, Rolde, Twitchell Committee Report: New Draft of LD 103

Amendments Adopted:

S-83 ESTES H-403 DIAMOND

SUMMARY: The original bill would require the State Liquor Commission to lower the prices in all state liquor stores to the same level as the price in the one "discount" state liquor store in Kittery.

The New Draft directs the State liquor Commission and the Bureau of Alcoholic Beverages, in conjunction with the University of Maine, to conduct a study on the feasibility and effects of uniform pricing of liquor. The study will

also cover all other aspects of the operations of the commission and bureau to improve efficiency, service and profits. The uniform pricing component of the study will be completed by the 2nd Regular Session; the remainder of the study will be completed by 1989. A 5-member subcommittee of the Legal Affairs Committee will oversee the study during the interim.

House Amendment "A" (H-161) (not adopted) would make a technical correction.

Senate Amendment "A" (S-83) adds an appropriation.

House Amendment "A" to Senate Amendment "A" (H-205) (not adopted) would clarify that the oversight subcommittee consists of Legal Affairs members. It also would correct the appropriation.

House Amendment "B" to Senate Amendment "A" (H-403) does what H-205 proposed, plus would require costs to be paid from the State Alcoholic Beverage Fund.

LD AN ACT RELATING TO QUALIFICATIONS FOR A HOTEL PL 1987 1645 LIQUOR LICENSE C. 232

Committee Report: New Draft of LD 787

SUMMARY: Current law requires that to qualify for a hotel liquor license, a hotel must be equipped with a certain number of hotel rooms in addition to the rooms used by the owner and employers. The original bill would delete the requirement that the number of rooms be in addition to those used by the owner or employees.

The New Draft accomplishes the same purposes and conforms to the recodification. It also makes a technical correction in the room requirements.

LD AN ACT TO AMEND THE LIQUOR LAWS AS THEY PERTAIN PL 1987
1655 TO STATE BREWERS C. 248

Sponsor: RAND, Coles

Committee Report: New Draft of LD 852

SUMMARY: The original bill would clarify the law as it relates to breweries.

The New Draft accomplishes the same purposes as the original bill, but it is redrafted to conform with the recodification of the liquor laws. It clarifies that any sampling of malt liquor, other than that done for quality
