c. 32 EMERGENCY

SUMMARY: Upon approval of the voters of both towns this bill allows the town of Pembroke to annex a portion of the town of Perry.

The original bill is somewhat unusual in 2 respects. First it calls for the Secretary of State to call and conduct the elections and requires that the procedures for a local option election be followed, which procedures are similar to those for a biennial election.

Secondly, the bill requires that 10% of the qualified voters vote in the referendum. Generally, this provision is worded as a % of those voting in the last gubernatorial election.

The House Amendment made the referendum requirement 10% of those voting in the last gubernatorial election.

SUMMARY: This Resolve is the annual county tax and authorization bill for York County.

AN ACT TO ESTABLISH THE AROOSTOOK WATER AND PL 1987 LD **1671** SOIL MANAGEMENT BOARD c. 435

SUMMARY: A recent study by the U.S. Army Corps of Engineers has tentatively determined that the adoption of controlled irrigation practices in conjunction with soil conservation measures will enhance the yield and quality of Aroostook County potatoes. The U.S. Congress has authorized \$3.4 million to implement a research and demonstration project as a follow up to the original study.

State and Local Government Part II County and Local

This bill sets up an Aroostook County Water and Soil Management Board consisting of 9 professional members who are to receive expenses only. The purpose of the Board is to coordinate all State and local efforts with respect to implementation of the research/demonstration program proposed by the U.S. Army Corps of Engineers. Staff to the Board is to be provided by the Department of Agriculture.

The federal legislation requires matching funds from the state equal to 35% of the total cost of the project. Since the Congress has set aside \$3.4 million, this would bring the state's share in the neighborhood of \$1.5 million. This bill authorizes the expedition by the Department of Agriculture of \$184,000 in the next two years and sets up a fund under the Commissioner to accept additional moneys. The bill indicates that it is expected that these will come from the Maine Geological Survey, the Potato Board, the University System and other state agencies. However, the bill contains no appropriations to cover such contributions by these organizations. It also has no appropriation to cover the expenses of the Board.

The Committee Amendment requires the persons appointed by the Maine Potato Board and the Aroostook County Soil and Water Conservation Districts be persons engaged in farming. It increases the number of persons on the board by two so that each Soil and Water District has a representative farmer. The amendment requires the Board to report to the Legislature at least annually on its activities and recommendations. The appropriation is deleted because it is in the Part 2 budget. An allocation is added for the federal funds expected for the project. The Board is created within the Department of Agriculture and the Commissioner shall implement the allocation of these funds to the Board.
