AN ACT TO ENSURE THE AVAILABILITY OF GROUP
ACCIDENT AND SICKNESS AND HEALTH INSURANCE TO
RETIRED TEACHERS

SUMMARY: The intent of both the original bill and the identical house (H-233) and senate amendments (S-121) was to provide retired teachers access to the group accident and health insurance plans at the same insurance rates paid by active teachers. The intent of the bill was also to give retired teachers the option of joining a new health insurance plan if the active teachers in the school unit in which they taught at retirement choose to join a new plan.

The bill was passed with the House Amendment.

An amendment attached to LD 1818 makes the life insurance provision effective for those retiring after January 1, 1987.

SUMMARY: The new draft of the bill largely made technical clarifications to the retirement statute and the manner in which it is administered. The major difference between the original draft and the new draft is the elimination of sections amending survivors benefits. The proposal was to allow a beneficiary the option of receiving the equivalent of a reduced retirement benefit based on the deceased members years of service. There was a separate bill dealing with survivors benefits and the committee decided to deal with changes in the survivors benefits in that bill.

The house amendment to the bill removed the requirement that the minimum of 10 years of service required for life insurance benefits to be carried into retirement be "continuous and immediately before retirement."
