SUMMARY

The bill makes small changes in the laws licensing hearing aid dealers and fitters. It changes the cycle of renewals, allows consumers to pay the full price at the time of purchase, allows licensees to recoup 10% of the cost if a transaction is cancelled, and limits the obligation of licensees to accept a cancellation of a hearing aid order.

The bill also amends the laws governing occupational therapists to make it clear there are two categories -- occupational therapists and occupational therapy assistants.

Finally, the bill amends the statutes concerning the licensing of plumbers. It increases the fees for licenses and examinations and increases the size of the board from 3 to 5. It clarifies the work hour requirements for licenses. Lastly, it stipulates that a master plumber can only be affiliated with one company.

The committee amendment added an allocations section. The House amendment added a transition for present members of the Plumber's Examining Board.
