H-309 SMITH

SUMMARY: The current law requires the State Liquor Commission to follow Administrative Procedure Act procedures for establishing an agency liquor store. This bill would give the Commission authority to license a temporary agency liquor store in an expeditious manner if a state liquor store is forced to close by a natural disaster.

House Amendment "A" (H-309) replaces the bill to allow the Commission to license a temporary agency liquor store to replace only the Gardiner State Liquor Store which was closed due to the flood in April, 1987.

SUMMARY: This bill would allow Alton Dishon to sue the Maine State Retirement System for up to \$50,000, for alleged misrepresentation on the part of agents of the System.

SUMMARY: This original bill and the New Draft arise from the Legal Affairs Committee Study, approved by the Legislative Council, to recodify Title 28. Changes suggested throughout the study by the Committee, the Bureau of Alcoholic Beverages, the Bureau of Liquor Enforcement and others are incorporated into the bill. These are changes that could not be made in the Recodification (LD 155) because they would change the effect of the law. The Statement of Fact contains a section-by-section analysis of the New Draft.

House Amendment "A" (H-340) (not adopted) would allow Class A restaurants and hotels to sell liquor on Sunday starting at 10 a.m. Current law prohibits the sale of liquor before noon on Sunday.

Senate Amendment "A" (S-197) (not adopted) would allow part-time, but not full-time, law enforcement officers to hold liquor licenses.

Senate Amendment "B" (S-210) retains a term of art for liquor pricing which is used in existing law.

PL 1987 c. 418 EMERGENCY

Sponsor: VOSE, Randall Committee Report:

SUMMARY: This bill was not referred to committee, but the committee worked with the sponsor in drafting the bill.

Under current law, licensees cannot sell liquor on Sunday if the municipality has not voted to approve the Sunday sale of liquor through a local option election. There are several municipalities which have not held a local option election for Sunday sale of liquor, but are not aware that such sales cannot be made. This bill allows licensees in these municipalities to continue to sell liquor on Sunday through August 15th if the municipal officers approve.
