### SUMMARY

The bill and committee amendment created reciprocal permits and charges on transporting certain products into Maine when other states or countries impose these permits or charges on Maine residents who transport these products into those other states or countries. The House amendment added an emergency.

### SUMMARY

CALLAHAN

The bill does the following:

1. It creates combination license, \$20, for vehicles used interchangeably for the conveyance of passengers or property.

2. It creates a \$2 license fee for motor vehicles used for the conveyance of passengers on islands having no roads maintained by the state.

3. It allows trucks weighing less than 6000 pounds to be registered as automobiles.

4. It provides for a \$10 registration fee for electrically powered passenger vehicles under 6000 pounds.

5. It removes the licensing requirement for gasoline powered trucks and busses since the gasoline users tax has bee repealled.

6. It provides for a temporary registration for vehicles delivered from overseas. The temporary registration can only be used to transport the vehicle from the dock to a temporary storage yard.

7. It exempts trucks which are engaged in snowplowing or ice control for the state or a municipality from truck weight limits.

The committee amendment struck the provision exempting snow plows from the weight limit. It also clarified that vehicles with 3 or more axles only need to register under the Special Fuel Tax if they meet the 26,000 pound weight criteria of the law.
