SUMMARY

This bill allows the town of Island Falls to annex township 4, range 3 WELS in Aroostook County.

This bill is a carry over from the last session. The original bill sought to accomplish its purpose by having the Legislature ratify a vote which had been taken by the town of Island Falls.

The effect of this annexation will be to increase the Island Falls tax base by the current valuation of this township and decrease the base of the unorganized territory by an equal amount.

Committee Amendment A (H-437) requires another referendum including both the voters of the township and the voters of the town. The two entities are to vote as one body.
