

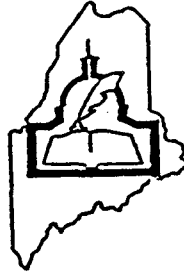

Section 3 would have prohibited the molestation of fishing gear, including aquaculture gear set by a person holding a finfishing license, but this section was removed by House Amendment (H-562).

Section 4 repeals the sunset on a provision permitting the taking of quahogs greater than one-half inch if they were raised by means of aquaculture.

Section 5 permits crews of more than two members to be covered under a mussel boat license.

SUMMARY

This bill, submitted by the Department of Marine Resources was intended to clarify the authority of marine patrol officers to conduct safety inspections and to update the language in the statute relating to the search and seizure authority of marine patrol officers.

The majority Committee amendment further clarifies the authority of marine patrol officers, and more directly identifies the scope of that authority.

The minority amendment would have limited safety inspections to verification of safety requirements contained in rules of the Department of Inland Fisheries and Wildlife and further limits the authority to search to periods when engaged in licensed activities. It also prohibits warrantless searches of living quarters unless otherwise allowed by law.

SUMMARY

This bill would change the title of "volunteer marine patrol officer" to "deputy marine patrol officer" and give them the power to enforce all laws enforced by marine patrol officers, not just marine resources laws.

Majority ONTP report accepted in House. Minority OTP accepted in Senate.
