All Adopted Amendments are listed, by paper number (e.g., H-584 or S-222), together with the sponsor for floor amendments. Final action is listed to the right of the title. If final House and Senate action differ, both are listed. Committee Reports and Floor Action are indicated as follows::

SUMMARY

LD 2077 proposed to adopt the uniform law regarding the filing of federal liens.

Committee Amendment "A" (H-482) added an omitted cross-reference and made technical corrections to the LD in order to maintain consistency with present filing requirements relating to personal property, farm products and oil, gas or mineral interests.

SUMMARY

The bill sought to provide a limited immunity from civil suit to individuals or corporations donating time to health care providers as long as that conduct was not wanton or willful. This issue, insofar as it concerns individuals, is addressed in LD 2520.

SUMMARY

The bill sought to require the court in a divorce or annulment proceeding involving minor children to make its decrees and inquiries of the parties and their attorneys so as to discourage or prevent bargaining tactics that seek to link parental rights and responsibilities with separate issues of property disposition.
