#### SUMMARY

This bill sought to establish a screening program to detect elevated levels of alpha-fetoprotein to help prevent handicapping conditions, and authorize the Department of Human Services to adopt rules to regulate the program and provide for patient support services.

#### SUMMARY

This bill sought to provide a short-term, immediate response to the shortage of personnel in certain health care occupations. It established 3 programs.

- 1. A job and skill training program for certified nurses aides and home health care aides;
- 2. A job and skill training program for certain technical, hospital based occupations; and
- 3. An educational loan program for nurses.

The majority committee report (S-468), which was accepted, made several technical language changes and established the Department of Labor and the Department of Human Services as the Coordinating Agencies. Certification for training will be granted by the Department of Educational & Cultural Services. The majority report, as in the original bill, funded the nurse loan program by passing through the costs as an adjustment by the Maine Health Care Finance Commission.

The minority committee report (S-469) differred from the majority report only in that the nurse loan program would have been funded through a General Fund appropriation.

All three programs are sunsetted in 3 years.

The Senate amendment (S-513) removed the appropriation to the Department of Labor, which was included in the supplemental budget.

Another amendment (S-490), which was not adopted, would have eliminated the nurse loan payback program.

#### SUMMARY

This bill enacted the Additional Support for People in Retraining and Education Program (ASPIRE). This bill was the subject of many deliberations by the committee. The final version, as amended, provided as follows:

- l. authorizes the Department of Human Services to participate in the determination of eligibility for various subsidies of telephone costs for low-income people as established by the Public Utilities Commission.
- 2. authorizes the Department of Human Services to seek a waiver from federal regulations regarding eligibility requirements for Aid to Families with Dependent Children (AFDC) benefits. If the waiver is approved, recipients with children as young as 3 years old would be required to register in the ASPIRE Program in order to be eligible for AFDC benefits. Current law would require recipients with children as young as 6 years old to register in the ASPIRE Program. Certain exemptions which exist in the current federal laws and regulations would still apply to the recipients with the younger children. Recipients who have children with special needs will not be required to register. Under this bill, recipients who volunteer are given priority for the ASPIRE Program support and services.
- 3. enacts a mandatory registration requirement for the Family Services Program (FSP) for teenage parents who are recipients of AFDC. Failure to register and actively participate in the program will not result in ineligibility for basic AFDC benefits; however, supplemental support services, such as child care and transportation, may be withheld pending participation in the program.
- 4. includes first-time pregnant women in the AFDC program during the last trimester of their pregnancy.
- 5. requires the Department of Human Services to notify the Joint Standing Committee on Human Resources of any request for waivers from the Federal Government concerning the AFDC, WEET, and ASPIRE Program and the Emergency Assistance Program.
