## SUMMARY

GWADOSKY

This bill establishes the Maine Educational Loan Authority. As originally drafted the purposes of the authority are to provide supplemental loan assistance to students for post-secondary study and to assist post-secondary institutions in financing expansion of their facilities. The authority is authorized to issue and sell bonds and to use the funds from that sale to accomplish those purposes. Thirty-five million dollars of the state's \$150 million bond ceiling for 1988 is allocated to the authority and a cap of \$50 million is established for authority bonds outstanding at any given time. A 7-member board is established to operate the authority.

REPORT

The committee amendment deletes authority to finance higher education facilities from the authority's duties because that responsibility is performed by the Maine Health and Higher Education Facilities Authority. amendment also makes several necessary changes in the original bill, including providing for legislative review and confirmation of the public members, requiring an annual report by the authority to the Education Committee (the original bill required reporting to the Governor, the Speaker of the House and the President of the Senate) and establishing a sunset review cycle for the authority.

#### SUMMARY

After they were not included in the second errors bill of the Session, the provisions of this bill were introduced and referred to the Education Committee on the last day of the Session. The bill provides that a vacancy may be declared on a school board or school committee in a school administration district, a community school district or a municipal school district if a member is absent without excuse from three consecutive regular board or committee meetings.

The Senate amendment provides that the vacancy provisions of the bill do not apply in municipalities which are governed by a municipal charter.
