#### SUMMARY

This bill, on the recommendation of the State Liquor Commission, increases the revenues generated from fees for retail liquor licenses. The bill requires part time license holders to pay the same fee for a 6 month license as others pay for a full-time (one year) license. The commission determined that elimination of the part time license fee would generate an additional \$111,875 per fiscal year.

#### SUMMARY

This bill corrects an error in the recodification of the liquor laws. The bill raises the fee for a part-time Class VI retail license from \$62.50 to \$67.50. In addition, the bill repeals a \$10 surcharge imposed on full-time Class VI licenses.

The gist LD 53 was incorporated into a committee amendment to LD 56, a companion piece of legislation.

### SUMMARY

This bill, in conjunction with LD 53, corrects an error in the license fee for part-time Class VI licenses. LD 56 adds a \$5 surcharge to these part-time licenses. The Bureau of Alcoholic Beverages, believing that the license fee had been raised \$5 in legislation passed during the 113th Legislature, had been collecting this additional \$5. Authorizing collection of this surcharge as of September 28, 1987, LD 56 legitimizes collection of this additional \$5.
