SUMMARY

This resolve stemmed from an interim recommendation of the Commission on Manufactured Housing, created by Private and Special Law 1987, chapter 139. The resolve requires the Manufactured Housing Board to produce a pamphlet, for distribution by retail sellers of manufactured housing, designed to educate potential buyers about aspects of ownership and selection of manufactured housing.

SUMMARY

This bill implements interim recommendations of the Manufactured Housing Commission, created by Private and Special Law 1987, chapter 139. See also LD 59 and LD 62. LD 60 deals with 3 of the commission's recommendations.

First, the bill amends the law regarding membership on the Manufactured Housing Board. The bill adds 3 additional manufactured housing owners to the board and brings the total to 4, the number of manufactured housing dealers on the board. The bill requires that 3 of the 4 homeowner representatives live in a mobile home park or similar rental community. A transition provision in the bill provides that, notwithstanding the bill's changes, current board members may serve until the expiration of their terms.

Second, the bill requires a licensed installer who installs a new or used mobile home, on a private lot or in a mobile home park, to notify the Manufactured Housing Board. The bill authorizes the board to collect up to \$10 per installation to cover administrative costs and the costs of responding to consumer complaints.

Third, the bill amends the law regarding design standards applicable to mobile homes.

The bill also allocates money derived from the installation notice fee to provide for one full-time compliance officer and one part-time clerical staff person.
