SUMMARY

This bill allocates \$284,001 in additional money from the Highway Fund to the Department of Public Safety for FY 1988-89: \$197,378 for increased cost of health and dental insurance; \$36,896 for overtime related to the strike in Jay; \$33,420 for increased gasoline costs. The bill also 2 allows adjustments by the State Budget Officer with approval of the Governor, and allows 1 year carry-over.

CA (H-12) The amendment deletes \$2,550 for a new state telephone system, which is undergoing further review. Accordingly, the allocation and the Fiscal Note are reduced to \$281,451. The amendment deletes Sec. 2, since authority exists for transfer of unexpended balances and for allocation of funds from the unallocated highway fund surplus.
