SUMMARY

The original bill sought an exemption from seaweed permit requirements for noncommercial harvesters of seaweed of less than 1,000 pounds per year.

The committee amendment replaced the bill. The bill, as enacted, restructured the entire section dealing with seaweed permits to more clearly show the exemptions to the permit requirement. It added exemptions for harvesting of not more than 50 pounds of seaweed a day, for a charitable or municipal organization's personal use, and for seaweed which has detached naturally and is dead.

SUMMARY

This law, the product of a study conducted by the legislative Commission on Marine Research, establishes a Marine Research Board with the authority and resources to identify and fund marine research needs that are not currently being addressed. The board will be composed of the representatives of the major users of and contributors to the marine research field. In addition, the board is charged with coordinating available data on the Gulf of Maine and developing a facility needs plan. As enacted, the grant program and the facility needs plan are subject to available funding.

This bill originally sought to stabilize 10 federally funded positions in the Department of Marine Resources's Bureau of Marine Science by funding them through the General Fund. Funding was also sought for 2 positions in the department's Boothbay Harbor library that are partially funded by a private laboratory. The bill, as enacted, deleted funding for those 12 positions.
