



All Adopted Amendments are listed, by paper number (e.g., H-584 or S-222), together with the sponsor for floor amendments. Final action is listed to the right of the title. If final House and Senate action differ, both are listed. Committee Reports and Floor Action are abbreviated as follows:

This bill, as enacted, established a bear hunting permit which will be required, in addition to a big game hunting license, to hunt for bear prior to the opening of the firearm season on deer.
