SUMMARY

The bill proposed an amendment to the foreign language provisions of the high school curriculum laws to allow high schools to offer Braille and Nemeth Code (mathematics) courses for foreign language credit. Current law permits foreign language credit to be given for American sign language.

The committee amendment replaced the bill with language permitting elementary and secondary schools to offer Braille and Nemeth Code courses as part of their curriculum (not just as a foreign language) and to determine what credit will be given for the course.

SUMMARY

This bill would have prohibited the state from collecting a guarantee or administrative fee on Guaranteed Student Loans. A general fund appropriation was included in the bill to compensate for the revenue that would have been lost.
