#### <u>SUMMARY</u>

This bill provides the supplementary allocations from the Highway Fund for Fy 1989-90 and 1990-91, including about \$1.1 million the first year and \$800,000 the second to fund the 50% Highway Fund share of 22 new people in the Bureau of State Police, full funding for 4 new people in the safety program, and capital and contractual funds to upgrade the mini computers at the Division of Motor Vehicles.

CA (H-577) revises the supplemental allocations and makes several other changes as follows:

Sections 1, 2, and 7 provide for a special registration and inspection for altered vehicles, including vehicles with body lifts. These would be subject to standards to be adopted by the Chief of the State Police. The registration fee would be \$27 per year, the same as a street rod, and the fee for the additional inspection would be \$15. These provisions would take effect March 1, 1990.

Section 3 deals with evasion of the fuel decal requirement by establishing a minimum fine of \$250 for failure to obtain and display a fuel use decal.

Section 4 deals with the islands in Penobscot Bay in which 75% of the vehicle registration fees must be spent by adding Frenchboro and Islesboro to the list.

Sections 5 and 6 deal with posted roads, making it clear that the prohibition applies to loaded vehicles with a registered gross weight exceeding the limit allowed by chapter 303 of the DOT rules, and making the minimum fine \$250 for operating overweight on a posted road, not to be suspended.

HB (H-606) increases motor vehicle inspections fees to cover the shortfall in the highway budget, as proposed in LD 70.

#### **SUMMARY**

Under present law, effective April 1, 1989, vehicle registrations expire as follows:

Automobiles; newly acquired motor truck and truck tractors; newly acquired motorcycles, mopeds and motor driven cycles: end of the month, one year from the month issued.

Other vehicles (trailers, semi-trailers, special mobile equipment...): March 1 to the last day of February of the next calendar year.

The bill would change the provision for other vehicles (trailers, etc.) to the last day of the month, one year from the month issued.

Present law requires registration plates to have an illustration of a red lobster and the words, "Maine" at the top and "Vacationland" at the bottom. There was a new general issue, July 1, 1987. The next is scheduled for 1993.

This bill provides that each county may select a design logo for registration plates for residents of that county, beginning July 1, 1989.

#### SUMMARY

This bill requires law enforcement officers to deter excessive speed through visible law enforcement rather than concealment of officers in speed traps. Evidence by a law enforcement officer in violation of this visibility requirement is not admissible in court against a person charged with speeding.

In addition, this bill prohibits the use or installation of radar detectors in motor vehicles in this State. A person violating this provision commits a traffic infraction punishable by a fine of at least \$50 and upon a person's 3rd offense, the law enforcement officer shall confiscate the radar detector.
