All Adopted Amendments are listed, by paper number (e.g., H-584 or S-222), together with the sponsor for floor amendments. Final action is listed to the right of the title. If final House and Senate action differ, both are listed. Committee Reports and Floor Action are abbreviated as follows:

### SUMMARY

The bill reestablished a penalty for trespass by animals.

The committee amendment rewrote the original bill to clarify the intent and implementation of the penalty, and required law enforcement agencies to inform the owner of a trespassing animal. In cases where the owner cannot be found or does not remove the animal when told, the law enforcement agency can remove the trespassing animal at the owners expense. H-92 added an emergency preamble and clause.

In August 1988, federal legislation created the National Institute of Standards and Technology as the successor organization to the National Bureau of Standards. The National Institute of Standards and Technology will retain all of the traditional functions of the National Bureau of Standards and will assume several new roles as well.
