This bill would provide that the Department of Human Services may not establish a maximum limit on reimbursement for adjustments to the prospective rate for nursing staff wages. The Committee Amendment (H-436) adds an appropriation.

SUMMARY

This bill ensures that any money received as a result of a successful Agent Orange claim or settlement will not be used to reduce the amount of public assistance received by an individual.

The Committee Amendment "A" (H-39) adds a fiscal note to the bill indicating that the costs of implementing this legislation cannot be determined at this time because federal legislation is pending which would allow the exclusion of Agent Orange award money in determining eligibility for assistance. It also defines Agent Orange and adds an emergency preamble.
