This bill requires that paintings that have not been independently created, executed and signed by the individual artist be labeled clearly to show the place of origin of that painting and to state that the painting is not an original.

SUMMARY

This bill prohibits the rental company from holding the renter liable for damage to a rented vehicle except under certain conditions and prohibits the offering of a waiver to cover those exceptions.

Committee Amendment "A":

- 1. Allows the term "authorized driver" to be defined by contract;
- 2. Allows the private renter of a truck to use it to transport any furniture, not just his own;
- 3. Changes the definitions of operating under the influence of alcohol or drugs; and
- 4. Delays the effective date until January 1, 1990.

LD 230 An Act to Amend the Charitable Solicitations Act **PUBLIC 55**

SUMMARY

Recent court decisions have invalidated major portions of the Charitable Solicitations Act, which requires professional fundraisers to disclose information to prospective donors. This bill changes the law to conform with the court rulings.

This bill makes the following changes in the Charitable Solicitations Act:

- 1. Enables the Department of Professional and Financial Regulation to charge a small registration and renewal fee to fund the program.
- 2. Makes the filing of the required financial reports coincide with the annual renewal deadline.
- 3. Removes the requirement that charitable organizations, exempt from the registration provision, file an exemption statement with the Department of Professional and Financial Regulation.
- 4. Removes the requirement that professional fund raisers disclose that fact when conducting solicitations, if less than 70% of contributions will be for program services, and to disclose what percent of contributions will go to fund raising expenses.

Committee Amendment "A" adds an allocation section and a fiscal note to the bill.

The purpose of this bill is to extend the transition period for implementation of the new qualifications for the various types of real estate licenses which was passed in 1987 from June 30, 1988 to June 30, 1989.
