SUMMARY

Currently, the Department of Inland Fisheries and Wildlife is required to designate as an agent for the sale of nonresident hunting and fishing licenses any business which makes an application. A \$30 fee is required for being an agent.

This bill eliminated the requirement that the department designate any business and eliminated the fee for those businesses that are selected. The committee amendment required the department to promulgate rules establishing criteria for the selection of agents.

SUMMARY

This bill originally provided for an additional 500 moose hunting permits, but left the maximum number of permits available for non-resident hunters at 100. The committee amendment changed the title and deleted that portion of the bill which would freeze the number of nonresident permits at 100. Instead, the current practice of allowing up to 10% of the total number of permits issued to be nonresident and alien permits would have continued. (See also LD 101)

This bill sought to allow Maine residents to hunt deer on Sundays during the regular open season on deer.
