This document is a compilation of the bill summaries prepared by this office for the Joint Standing Committees and Joint Select Committees of the Maine Legislature. The summaries are arranged by LD number for each committee.

All Adopted Amendments are listed, by paper number (e.g., H-584 or S-222), together with the sponsor for floor amendments. Final action is listed to the right of the title. If final House and Senate action differ, both are listed. Committee Reports and Floor Action are abbreviated as follows:

OTP	Ought to Pass
OTP-ND	Ought to Pass in New Draft
OTP-ND-NT	Ought to Pass in New Draft, New Title
OTP-A	Ought to Pass as Amended
ONTP	Ought Not to Pass

SUMMARY

LD 344 proposed that state agencies provide proposed agency rules along with fact sheets to the director of the legislative office which reviews proposed agency rules. The director would review each rule with respect to:

- A. Clarity;
- B. Sufficient statutory justification of the rule;
- C. Sufficient statutory standards for the rule;
- D. The extent to which and how well the proposed rules achieve the purpose for which they are proposed.

Following the review of a proposed rule, the director of the legislative office on rules would send a copy of the director's comments and recommendations to the agency proposing the rule and to each member of the committee with jurisdiction over the subject matter of the proposed rules.

The Committee agreed to consider the contents of LD 344 in conjunction with its consideration of a more comprehensive bill concerned with rulemaking.
