SUMMARY

This bill allows storage of liquor directly imported into the State in a warehouse facility under the direct supervision and control of the agent of the certificate of approval holder importing the liquor in addition to a facility under the holder's personal supervision and control. The intent is to allow these importers to use public warehouse facilities.

Committee Amendment "A" allows storage in a public warehouse with the approval of the State Liquor Commission.

House Amendment "A" clarifies the committee amendment.

This bill allows the Bureau of Alcoholic Beverages to issue licenses authorizing the sale of fortified wines, such as port and madeira, in off-premise retail establishments.
