SUMMARY

Present law (24-A MRSA §2164-C) prohibits insurers from requiring appraisals or repairs of window glass to be done at any particular establishment. This bill would make violation a Class D crime and subject to loss of license.

AMENDMENTS ADOPTED

SUMMARY

The bill provides an income tax credit for employers who pay at least 50% of the health insurance premium for their employees, and who have not provided health insurance for their employees for the past three years. The credit would equal 20% of the employer's premium expenditures in the first year, and 10% in the second year. The employer must have more than one and fewer than fifty unrelated full time employees, and must offer the health insurance to at least all full-time employees. The tax credit would be available for tax years beginning on or after January 1, 1990 and ending on or before December 31, 1992.
