### SUMMARY

The purpose of this bill was to allow filling areas that are closed to the harvesting of clams or other marine mollusks because of the presence of a municipal sewerage treatment discharge. However, these areas have significant and important values even when closed to shellfish harvesting. The Committee felt the language was too broad and voted not to pass the bill.

SUMMARY

This bill unifies the existing energy efficiency building standards to create a uniform, mandatory standard for residential and commercial buildings.

The bill amends the Energy Efficiency Building Performance Standards by conforming it to the mandatory building standards enacted under Public Law 1987, chapter 818 and by repealing the now unnecessary voluntary standards and the separate mandatory publicly funded standards. It also establishes an energy efficiency standard for all residential buildings of more than 2 dwelling units. These standards are similar to the standard now used for publicly funded multiple unit residences.

The Committee amendment (H-45) added an emergency preamble and clause to the bill and made a technical change. H-60 corrected a technical error.

### SUMMARY

This bill, as amended by H-331, allows the Director of the Bureau of Public Lands to deny an application for a submerged lands lease if the director determines that the lease will interfere with public access to, or public trust rights in, on or over these state-owned lands. This amendment also adds a fiscal note.

The original bill also proposed to include the review of traditional accessways as part of the review under site location of development laws.
