#### SUMMARY

The original bill would have required the Maine Milk Commission to ensure that distributors deliver milk to convenience stores and other small outlets requesting deliveries.

The committee amendment replaced the requirement in the original bill with a more modest requirement that a distributor give 30 days notice of cancellation of deliveries to any customer in their delivery area or the traditional delivery area of a distributor they have purchased. The 30 day notice does not apply to cancellations based on a failure to pay bills.

This bill would have revised licensing procedures and restrictions for harness racing. Amendments in granting of licenses, license fees and license revenues were proposed. An amendment to allow concurrent racing at tracks within 50 miles of each other was also proposed. See LD 292 for related action.

### SUMMARY

The bill established the position of Agricultural Training and Education Specialist in the Department of Agriculture, Food and Rural Resources to assist producers and other employers of farm workers to recruit and retain workers. In addition, it set up a 7 member Advisory Committee on Agricultural Labor Recruitment.

An appropriation of \$36,693 for FY 90 and \$44,854 for FY 91, would have provided funds for a Training and Education Specialist, a part-time Clerk Typist and anticipated expenses of the Advisory Committee on Agricultural Labor Recruitment.

The bill did not receive funding and was indefinitely postponed.
