LD 657 An Act to Discourage the Theft of Blueberries

SUMMARY

The bill made it a crime for any person to harvest, possess or remove blueberries from the land of another without written permission of the land owner. It also made it a crime to transport blueberries without a permit. Finally, the bill made it a crime to receive blueberries without inspecting the transportation permit and recording the source of the blueberries and the identity of the driver.

The amendment made a number of substantive changes in the bill. An exemption in Section 4314 for persons harvesting or removing less than 5 pounds of blueberries from the land of another without permission was removed.

Section 4315 was amended to increase from 5 to 25 pounds the amount of blueberries requiring a transportation permit. Provisions exempting the transport of non-native blueberries and blueberries purchased at a retail outlet were rewritten for clarity and included as sub-section 4. The penalty for transporting without a permit is reduced from a Class D to a Class E crime. Forging a permit was reduced from a Class D crime to a civil violation with a fine of not more than \$500.

The penalty in section 4316 for failure by anyone receiving more than 5 pounds of blueberries to inspect, record and retain a record of the transportation permit number is reduced from a Class D crime to a civil violation with a fine of not more than \$1,000.

The amendment adds language to repeal the bill's provisions on July 1, 1991.
