#### SUMMARY

This bill assigns responsibility for the State's motor fuel pump-top price sign law to the Department of Agriculture, Food and Rural Resources, Office of Sealer of Weights and Measures, as well as creating penalties for failure to post the signs as required by law. The bill also corrects a technical error in current law regarding the assignment of section numbers.

Committee Amendment "A" adds a fiscal note which indicates that all costs occasioned by the bill can be absorbed by the departments involved.

#### SUMMARY

This bill establishes new requirements for the licensure of professional foresters. A 2-year internship approved by the State Board of Licensure for Professional Foresters will be required for licensure beginning in 1990. Passage of a written or oral exam will be required beginning in 1991.

Committee Amendment "A" states that interns need only work under the guidance, not the personal supervision, of a licensed forester.

### SUMMARY

Currently, state law prohibits life insurers from owning funeral establishments. This bill places the same restrictions on arrangements between insurers and cemeteries and crematories.

This bill also subjects fraternal benefit societies to the same restrictions concerning arrangements with funeral homes which now apply to commercial insurers.
