LD 697 proposed to allow persons 18 years old or older to circulate popular initiative petitions.

Committee Amendment "A" (S-40) replaced the 18-year old requirement and allowed any registered voter to circulate petitions. It also clarified that the petition circulation requirement applied to municipal initiatives as well as state initiatives.
