This bill requires any public or private agency licensed by the Department of Human Services or the Department of Mental Health and Mental Retardation that provides care or services to children to develop and make available to staff, clients and the public a written statement outlining the agency's policy with regard to child abuse and neglect. Policies developed pursuant to this bill must be filed with the licensing or regulating state agency or department as part of the agency's application for licensure or renewal.
