All Adopted Amendments are listed, by paper number (e.g., H-584 or S-222), together with the sponsor for floor amendments. Final action is listed to the right of the title. If final House and Senate action differ, both are listed. Committee Reports and Floor Action are abbreviated as follows:

SUMMARY

This bill enables the Department of Human Services to seek information from various sources relating to responsible parents who are not complying with family support obligations. The Committee Amendment (S-103) authorizes the Department to seek the same information with regard to Medicaid recipients.

SUMMARY

This bill requires any public or private agency licensed by the Department of Human Services or the Department of Mental Health and Mental Retardation that provides care or services to children to develop and make available to staff, clients and the public a written statement outlining the agency's policy with regard to child abuse and neglect. Policies developed pursuant to this bill must be filed with the licensing or regulating state agency or department as part of the agency's application for licensure or renewal.
