#### SUMMARY

LD 926 proposed that retiring classified state employees be authorized to run in a partisan election for a county or state office. The retiring classified state employee would be:

- A. required to submit a letter to the director of the employee's office stating his or her intent to retire and the date of retirement. The letter would be submitted within 12 months of the date of retirement:
- B. required to retire no later than December 1 following the general election, and the employee must be eligible to receive retirement benefits on the date of retirement;
- C. ineligible for future employment as a classified state employee.

The bill does not change current law concerning state employee solicitation of contributions.

The bill failed to receive committee approval because of public perception of state employees running for office in partisan elections. In addition, many committee members were concerned about the impact of the bill on the state employees (non-retirees).

#### SUMMARY

LD 956 proposes to increase from \$25 per day to the legislative per diem rate (\$55 per day) the amount of compensation provided to members of the Human Rights Commission. Proponents argued that the substantive work of the Commission as an adjudicatory board as well as the substantial work load placed on commission members.

The bill failed to obtain committee approval because of the absence of standards by which per diem is established for different types of boards.

The Human Rights Commission is one of 34 boards within the "General Government" category. Of the 34 boards, 27 boards are paid \$25 or no per diem whatsoever. A total of 6 boards are paid the Legislative per diem rate.
