#### SUMMARY

This bill contains the recommendations of the Blue Ribbon Commission to Study the Regulation of Health Care Expenditures. The original bill makes the following major changes;

- + It reduces the scope of projects subject to certificate of need review.
- + It changes the hospital regulatory body from a part time five member commission to a three member full time commission.
- + It provides more flexibility in the hospital rate setting process to permit increased competition and to reward hospitals which are efficient.
- + It establishes a \$30,000,000 fund to be used to compensate hospitals for losses resulting from governmental shortfalls and charity care.

This bill was amended in Committee and ultimately incorporated into LD 1322. (See summary of LD 1322 under Banking and Insurance Committee, above.) The provisions resulting from LD 920 which were incorporated into LD 1322 did not change the structure of the Maine Health Care Finance Commission but did make changes in the regulatory system to provide more flexibility and a greater role for competition. The Commission will study appropriate methods of regulation of outpatient services and a study commission is established to study health planning and certificate of need and the advisability of deregulating ambulatory health services. The enacted version provides approximately \$5,000,000 for uncompensated care.

### SUMMARY

The original bill appropriates funds to provide one adult protective services caseworker in each of Regions I, IV and V, and a supervisor in Region III. The bill also appropriates funds to place 3 mental health geriatric resource persons in unserved areas, and assessment and treatment funds to comply with the United States Omnibus Budget Reconciliation Act of 1987. This bill also funds 2 6-bed long-term psychiatric group residences to deinstitutionalize public wards who could safely live outside of Augusta Mental Health Institute and Bangor Mental Health Institute.

Committee Amendment "A" changes the appropriation section of the bill to reflect the funds needed by each of the named departments according to the fiscal note on the bill. It also changes the community mental health services section to provide funds for 2 geriatric mental health resource persons rather than 3, and directs the remaining funds to be used for treatment services in the affected regions. It also corrects a technical error.

This bill was carried over by the Appropriations Committee.
