

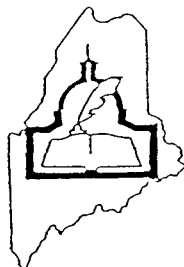

SUMMARY

This bill was carried over from the First Regular Session.

The original bill would permit intermediate care facilities for the mentally retarded to choose once every five years to have their reimbursement rates calculated on a new base year.

The Committee Amendment would have permitted a one-time opportunity for facilities to rebase their per diem rate and include the additional actual costs.

The Senate Amendment permits rebasing on the basis of allowable costs for the fiscal year ending in 1990.

H-733

SUMMARY

This bill was carried over from the First Regular Session.

The original bill would appropriate funds to provide one adult protective services caseworker in each of Regions I, IV, and V and a supervisor in Region III. The bill appropriates funds to place geriatric mental health resource persons in unserved areas and assessment and treatment funds to comply with the United States Omnibus Reconciliation Act of 1987. This bill also funds 2 6-bed long-term psychiatric group residences to deinstitutionalize public wards who could safely live outside of the mental health institutes.

Committee Amendment "A" corrects the appropriation section, changes the number of geriatric mental health resource persons to 2 and directs the remaining funds to be used for treatment services. It also corrects the references to federal law.
