SUMMARY

This bill makes possession of lobsters caught illegally a Class D crime and imposes a mandatory fine. In addition, this bill requires persons using traps or other containers to store lobsters in the coastal waters to clearly mark each trap or container with their wholesale or fishing license number and authorizes marine patrol officers to seize unmarked lobster containers that are in violation of the law and return the lobsters to their natural habitat.

SUMMARY

Compliance with the National Shellfish Sanitation Program will require that many of the classified shellfish growing areas in the State be closed to shellfish harvesting, pending the completion of field evaluations. Under current law, municipalities with shellfish ordinances that will be subject to the harvesting closures would be unable to manage or regulate shellfish resources. This law permits municipalities to regulate shellfish growing areas that are closed for harvesting by regulation of the commissioner.

The committee amendment replaced the original bill and provided a procedure for municipal officials to obtain approval to manage their shellfish resources by request to the Commissioner even though the area has been closed by regulation. It also made it clear that a municipality may issue licenses under its shellfish conservation ordinance even though the area has been closed by regulation.

The house amendment to the committee amendment added 2 provisions concerning nonresident licenses to the committee amendment. It required the total number of commercial licenses for nonresidents provided by those municipalities which have entered into an agreement with one another for joint or cooperative licensing action under their shellfish ordinances to be not less than 10% of the combined total number of licenses issued for residents. The amendment also prohibited shellfish conservation ordinances from discriminating between residents and nonresidents once they have obtained a shellfish license. These provisions will take effect January 1, 1990, to avoid interfering with the current clam season.

In addition, the House amendment restructured the Maine Revised Statutes, Title 12, section 6671, subsection 3 into 2 subsections, subsections 3 and 3-A in order to clarify the current law.
