SUMMARY

The bill would have created an Integrated Pest Management Fund to develop and implement an expanded and improved integrated pest management program. It would have provided funds to implement IPM programs, to conduct research and demonstration projects on new IPM techniques and to examine the feasibility of private sector involvement in IPM programs. The bill also would have created an Integrated Pest Management Advisory Committee to advise the commissioner on the awarding of research and private sector grants and to advise the Cooperative Extension Service, which would have significantly expanded the size and scope of its current IPM involvement, on the development of its plan of work. Finally, the bill would have established reporting requirements of grant recipients.

The Senate amendment added an appropriations section of \$150,000 in each year of the biennium.

The bill did not receive funding and was indefinitely postponed.

SUMMARY

The bill would have repealed the farmland adjacency law and replaced it with a requirement that owners of farmland who apply or intend to apply pesticides or chemical fertilizers, register their farmland at their county registry of deeds office. See LD 949 for committee action on this issue.

SUMMARY

The bill provided an exemption to the statutory prohibition against the use of a live animal as a fund-raising device or in a raffle, contest, game or promotion in order to allow civic organizations to operate games such as "cow chip casino."

Committee voted not to pass the bill upon assurance by Animal Welfare Board that "cow chip" casinos would be allowed. Later action by the committee added the provisions of this bill to LD 528.
